**ADAMS COUNTY FAIR
INFORMATION FOR OPEN CLASS FAIR EXHIBITORS**

Adams County Fair is open to any Wisconsin residents for exhibiting.

Free Gate

All exhibits entered in Open Class must be the result of the labor of the person exhibiting and must have been made, grown or produced since the last fair.

One exhibitor in any premium number may make only one entry. The same animal cannot be exhibited in both Open Class and Junior Fair. Animals entered in-group classes can also be exhibited in a class for individuals.

1. For Purebred Livestock classes, registration, name and identification number must accompany the animal to the fair. The bonafide owner thereof or his authorized agent must enter all animals or articles. Any animal or article must be marked with a card which will be furnished by the secretary designating its class and premium number, which must not be taken off during the continuance of the fair. All Purebred stock must be registered in the American Registry if such has been established and a certificate of registry or evidence of pure breeding will, in all classes, be required before examination in the show ring at the discretion of fair Officials.
2. All Scrapie tags/tattoos to be in place before the fair and a list be given to the fair secretary.
3. **Livestock Premises Id Number on entry blank. Premise ID** required for all livestock, poultry and rabbits. Register online at www.wiid.org, phone WLIC at 888-808-1910, or use paper forms available from DATCP or WLIC

ENTRY DAY INFORMATION

1. After online entries are received, judging sheets are produced and a tag is made for each entry. On entry day, Open Class exhibitors are to go to the Secretary's office to get their tags. Open Class exhibitors with a large number of entries may make arrangements with the Fair Secretary to receive their tags earlier.
2. All articles must be tagged and entered in the proper departments between 2:00 P.M. and 6:00 P.M. on Tuesday of Fair week. Department Superintendents and helpers will receive exhibits and place articles on display.
3. Livestock exhibitors will enter their animals between 8:00 A.M. and 4:00 P.M. on Thursday of Fair week. Livestock exhibitors should check with barn

superintendents for assigned space. Exhibitors must submit their livestock for examination for contagious disease by the official veterinarian, if requested, and must comply with all sanitary and animal health requirements. Rabbits and Poultry please follow the schedule. Dogs and horses cannot be kept at the fairgrounds. They are to be brought only for judging.

4. The Fair Association reserves the right to limit the number of exhibits per exhibitor in any department.

JUDGING

1. Judging will take place on Monday, Tuesday, Wednesday, Thursday, Friday, Saturday and Sunday of the Fair week. Premium stickers or ribbons will be attached to winning articles as soon as a decision is made.
2. In Open Class, regular judging is used.
3. Judges may disqualify articles, which do not meet the regulations and requirements. The judge is required to place exhibits in the premium category that he/she feels they merit.
4. The public may listen to the judge's comments, but are not to interfere with the judges or the superintendents or assistants while judging is in progress.

RELEASE OF EXHIBITS: Exhibits are to remain in place until 4:00 P.M. on Sunday.

1. Baked goods and garden entries become the property of the Fair and are destroyed at the end of the fair.
2. After exhibits are released, booths must be dismantled and the booth area left neat by the group that made the booth.
3. **ALL ARTICLES NOT CALLED FOR ON SUNDAY, (LAST DAY OF FAIR) FROM 4 TO 6 P.M. WILL BECOME PROPERTY OF ADAMS CO. FAIR.**

GENERAL INFORMATION

1. The officers of the Adams County Agricultural Society will take every precaution in their power for the safe preservation of stock and other exhibits, but will not be responsible for loss or damage that may occur.
2. The general supervision of the grounds and the entire exhibition at each and every annual Fair is vested in the Secretary, Liana Glavin for the Society. Exhibitors and others desirous of special privileges not granted in the published regulations must apply to her and all laborers on the grounds must be employed by her consent and subject to her direction.
3. Officers of the Society authorize the letting of such privileges or concessions as are required to supply the necessary wants of the people or that may add to their comfort, convenience, and pleasure; but under no condition will privileges of a questionable nature or of demoralizing tendency be let or in any manner be tolerated upon the grounds or in the buildings, nor will any privileges be permitted where the business is conducted in other than a legitimate and trade-like manner. The sale of alcoholic liquors and games of chance are strictly prohibited. Any violation of this rule will be severely dealt with.
4. Purchasers of privileges must keep their spaces in a sanitary condition by removing therefore all filth and refuse and by placing same in garbage cans provided.
5. Concessionaires and their employees and workers in food Stands must be neat and tidy in their dress. Persons found working at any privileges and not complying with this section may be ordered off the grounds.
6. The officers reserve the right to exclude from the grounds any person or persons who shall violate any part of the rules made by the officers of the Society.
7. Commercial exhibitors desiring booth space should apply to the Adams County Fair Secretary, P.O. Box 380, Friendship, WI 53934 for information.
8. No dormitory facilities are available. Camping privileges may be requested from the Fair Secretary.
9. The Fairgrounds are **NO SMOKING AREA.**
10. Due to lack of State Funding the Adams County Agricultural Society reserves the right to revise dollar premiums amounts in any given fair year.
11. No one will be allowed in or around the barns between 11:00 P.M. and 7:00 A.M. without proof of being an exhibitor.

12. Manure is to be put only in the designated area. We want to keep manure away from the barns to help prevent fires.

ADAMS COUNTY FAIR OPEN CLASS

HEALTH RULES:

STATE, COUNTY, DISTRICT ANIMAL HEALTH REQUIREMENTS FOR ALL ANIMALS. Exhibitors at County and District fairs are required to comply with all of the statutory and regulatory provisions of the State of Wisconsin relating to animal health.

All exhibitors must comply with the provisions set forth below. If a fair or livestock exhibition in this state last for more than 24 hours, the sponsors of the fair or exhibition shall appoint a licensed veterinarian to conduct daily inspections of all livestock at the fair or exhibition. The appointed veterinarian shall also review all records and test results required in these fair requirements. If a fair or exhibition lasts less than 12 hours, all records and test results required by these requirements shall be reviewed by a licensed veterinarian or by the show chairperson. The attending veterinarian shall conduct such test and examinations as may be necessary to determine the disease status of any animal and shall exclude or cause the removal of any animal afflicted with or suspected of being afflicted with any contagious, infectious or communicable disease.

HEALTH RECORDS

Persons exhibiting livestock at any fair or livestock exhibition in Wisconsin shall have a copy of the required health certificate or certificate of veterinary inspection available for inspection by the department at the fair or livestock exhibition, or file a copy of such certificates at the show or fair office for the duration of the exhibit. A health certificate or certificate of veterinary inspection is valid for 30 days unless extended by species.

PARASITES

Cattle infected with mange, scab, or ringworm may not be exhibited at any fair or other livestock exhibition. Animals found to be infected, or show evidence of infection shall be isolated from other animal susceptible to the disease and removed from the premises. This shall not apply to animals showing evidence of ringworm infection if in the opinion of the attending veterinarian of such fair or exhibition; the lesion is inactive and not capable of transmitting the disease.

WARTS

Bovine animals infected with warts may not be exhibited at livestock exhibitions. Animals with evidence of wart infection will be examined by the fair veterinarian and the animal ordered removed from the premises unless the veterinarian finds the warts are not capable of transmitting the disease.

QUARANTINE

LIVESTOCK UNDER QUARANTINE by the Department are not eligible for exhibition.

PENALTIES

Section 95.19 of the Wisconsin Statutes provides in part: "No person shall.... exhibit at any fair any animal afflicted with or exposed to any contagious or infectious disease". It is a misdemeanor to exhibit animals contrary to this section. In addition, it is provided that any person violating this provision shall be liable to any other person who sustains damage by reason of such violation.

DEPARTMENT 101-DAIRY CATTLE

CATTLE RULES:

- **MILKING COWS:** Exhibitors are responsible for providing a portable milking machine to

milk any cattle that are brought to the fair. Exhibitors are responsible for milking and properly disposing of any milk.

- In Dairy and Beef, Get of Sire, Name of Sire should be listed on the entry form and animals need not be owned by one exhibitor. Dry Cow, 3 years and older, must have milked 280 days or more since last Fair. DHIA Records to be used as proof.
- All exhibitors must follow health regulations and barn rules.
- Senior yearling heifers that have freshened should be entered as 2 year olds.

CLASS DEFINITIONS:

Individual Classes

Spring Calf- Born on or after March 1 of the exhibit year.

Winter Calf- Born between December 1 of year preceding exhibit year.

Fall Calf- Born between September 1 and November 30 of year preceding exhibit year.

Summer Yearling- Born between June 1 and August 31 of year preceding exhibit year.

Spring Yearling- Born between March 1 and May 31 of year preceding exhibit year.

Winter Yearling- Born between December 1 of the second year preceding exhibit year and February 28 or 29 of year preceding exhibit year.

Fall Yearling- Born between September 1 and November 30 of the second year preceding exhibit year.

2 Year Olds- Born between September 1 of the third year preceding exhibit and August 31 of the second year preceding exhibit year, and shall include yearlings which have freshened.

3 Year Olds- Born between September 1 of the fourth preceding exhibit year and August 31 of third year preceding exhibit.

4 Year Olds- Born between September 1 of the fifth year preceding exhibit year and August 31 of the fourth year preceding exhibit.

Dry Cow, 3 years and older- Must have milked 280 days or more since last fair. DHIA records to be used as proof.

Group Classes

Junior Get of Sire- Consists of 3 animals, which are the offspring of the same bull. All of these animals shall be under 2 years of age, and not more than 1 may be a bull.

Senior Get of Sire- Consists of 3 animals, which are the offspring of the same bull. All of these animals shall be 2 years of age or over. The exhibitor shall designate the name of the sire. A single exhibitor need not own the animals.

Produce of Dam- Consist of 2 animals of any age or sex, which are the produce of one cow.

Group of 3 Best Females- Consist of 3 animals of any age, which are bred and owned by the exhibitor.

Individual Classes:

Junior Calf- Born on or after January 1st of exhibit year. The calf must be 4 months old at time of exhibit to be shown.

Senior Calf- Born between September 1 and December 31 of year preceding exhibit year.

Summer Yearling- Born between May 1 and August 31 of year preceding exhibit year

Junior Yearling- Born between Jan 1 and April 30 of year preceding exhibit year

Senior Yearling- Born between September 1 and December 1 of the second year preceding exhibit year.

2 Year Old or Older- Born before September 1 the second year preceding exhibit year and which has calved during the preceding year.

Steer Classes:

Feeder Calf- Born on or after January 1 of the exhibit year and weighing less than 999 lbs. The calf shall be 4 months old at the time of exhibit.

Summer yearling- Born between May 1 and August 31 of year preceding exhibit year, and which has all milk teeth in place

Junior yearling- Born between January 1 and April 30 of the preceding exhibit year, and which has all milk teeth solidly in place and shows no nicking at the gums.

Group Classes:

Junior Get of Sire- Consist of 3 animals, which are the offspring of the same bull. All of these animals shall be under 2 years of age, and not more than 1 may be a bull.

Senior Get of Sire- Consist of 3 animals, which are the offspring of the same bull. All of these animals shall be 2 years of age or over. The exhibitor shall designate the name of the sire. A single exhibitor need not own the animals.

Produce of Dam- Consist of 2 animals of any age or sex, which are the produce of one cow.

Group of 3 Best Females- Consist of 3 animals of any age, which are bred and owned by the exhibitor.

2021 WILL BE A TERMINAL SWINE SHOW:

All swine exhibited at the fair must go directly to slaughter, they cannot return to the farm.

HEALTH RULES:

Veterinarian health check papers, original and a copy, must be shown for unloading Swine.

Gilt- A female swine that has not produced pigs and which has not reached an evident state of pregnancy.

Sow- A female swine that shows evidence of having produced pigs or is in an evident stage of pregnancy.

- Sheep originating within Wisconsin showing any symptom of contagious or infectious disease will not be permitted to show at any fair.
- Scrapie tag/tattoo to be in place before the fair. Bring a list of sheep, to be shown, and their number to the fair.
- All breeds shall show with two inches of wool or less.
- Breeding Stock cannot be shown in Market Classes.

Spring Lamb- Is one born on or after February 16th of the exhibit year.

Winter Lamb- Is one born between January 1st and February 15th of the exhibit year.

Fall Lamb- Is one born between September 1st and December 31st of the year preceding the exhibit year.

Yearling Ram or Ewe- Born outside the date of birth limitations in paragraphs above. The age of yearlings may be subject to verification by a veterinarian's examination, whose findings shall be final.

Mature Ewe- Born before January 1st of the year preceding the exhibit year.

Flock- Ram, ewe lamb, yearling lamb, and mature ewe

DEPARTMENT 106-HORSE & PONY

General Information:

1. The age of the horse is determined as of January 1st of the current year.
2. All horse must have a current year Coggins (original and copy) and proof of 4-way vaccination.
3. If a horse/ponies health is questionable, a show judge will be called and his or her decision will be final unless the judge feels it is out of his realm of knowledge a veterinarian will then be called. The horse's owner and or handler/rider will be responsible for all veterinarian expenses.
4. The area around the horse trailers must be cleaned and holes filled in before leaving the grounds after the show. A \$5.00 deposit per rider clean-up fee will be collected at registration on the date of the event. At the conclusion of the event, the \$5.00 deposit will be refunded upon approval of a current board member. If the area is vacated prior to approval, the deposit will be surrendered to the hosting club.
5. All horses must be supervised **AT ALL TIMES.**

Definitions:

SHOWMANSHIP – Judged on the exhibitor's ability to show the animal in hand.

HORSEMANSHIP/EQUITATION – Judged on the exhibitor's ability to ride under saddle.

PLEASURE – Judge on the horse/pony's performance under saddle or driving.
PONY – To be measured at 56" or less prior to showing.

DEPARTMENT 107-POULTRY

HEALTH RULES:

Poultry includes all species of fowl, wild and domestic. All poultry, except water fowl, shown in public exhibitions shall originate from flocks designated as U.S. Pullorum-typhoid Clean under the National Improvement Plan or from equivalent flocks, or shall have a negative Pullorum-Typhoid test within 90 days of movement to public exhibition. Only sexually mature birds over 4 months of age having a full complement of fully developed adult feathers are required to be tested. No poultry of any type or class showing any evidence of disease may be exhibited at any fair. If at any time any fowl in this group shows evidence of a contagious or infectious disease, it shall be removed from the exhibit and slaughtered or quarantined as directed by the Wisconsin Department of agriculture, trade and Consumer Protection.

PLEASE CHECK YOUR BIRDS FOR EXTERNAL PARASITES (I.E. LICE AND MITES) BEFORE THE FAIR AS WELL AS FOR COMMON AILMENTS SUCH AS SCALY LEG. If any of these do exist, please treat them before showing your birds.

- Exhibitors must feed & water their own birds. You must bring water dishes, feed dishes, and feed for your own birds.
- Clean cages during the fair and keep the walk area neat and tidy.
- If unsure of the origin of breed, i.e., American variety, please check the Standard of Perfections Book, available at the UWEX office, to ensure the bird is entered into the right class.
